THE FESTIVAL INCLUDES AN ARRAY OF EDUCATIONAL EXHIBITS, A FILM AND LECTURE SERIES, MUSIC AND STREET ENTERTAINMENT, GUIDED ARCHITECTURAL TOURS, A CLASSIC CAR SHOW, AND MANY VENDORS OFFERING ANTIQUES, DECO-INSPIRED ART, VINTAGE MERCHANDISE, AND CRAFTS.
